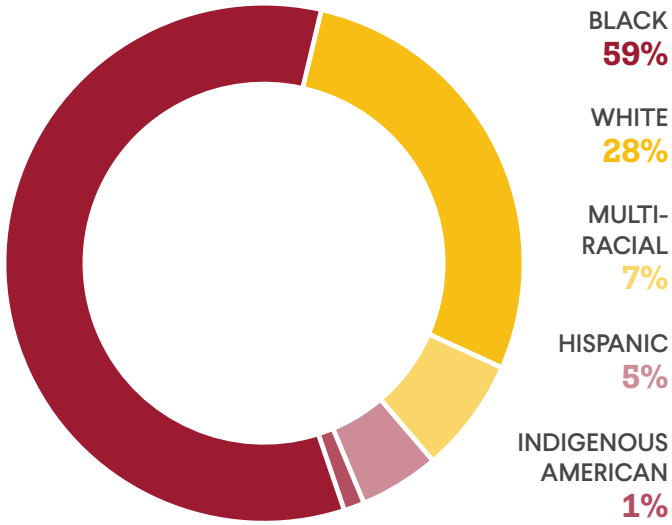

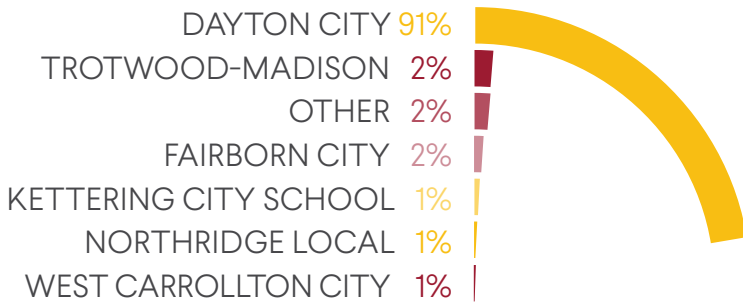

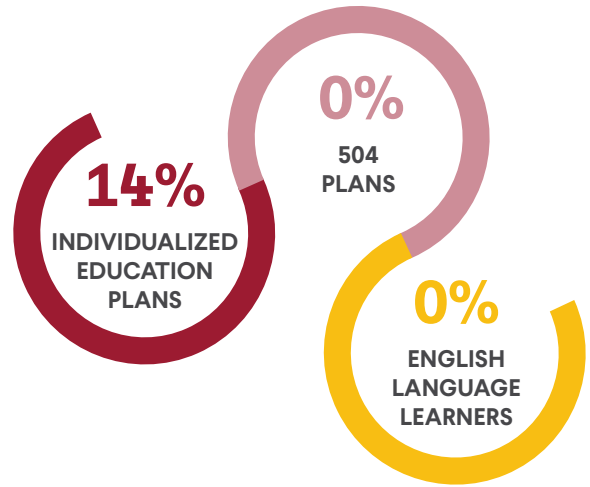
DISTRICTS OF RESIDENCE

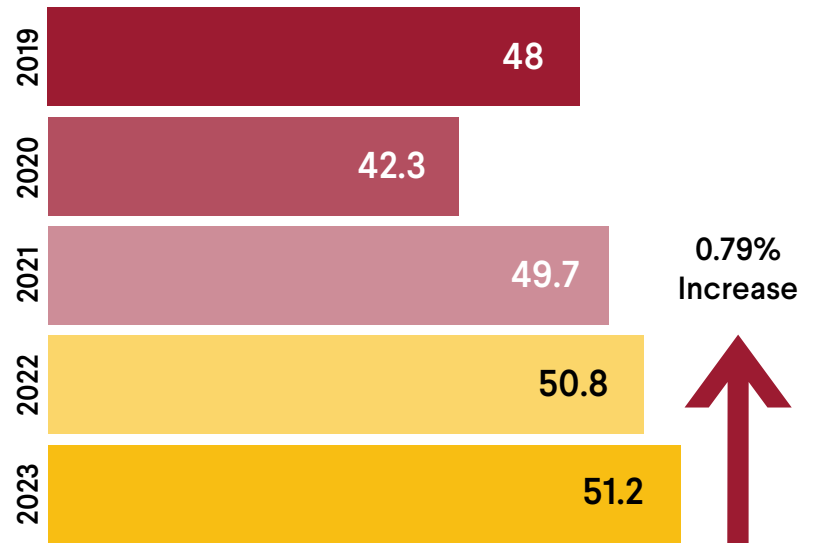
HIGHLIGHTS

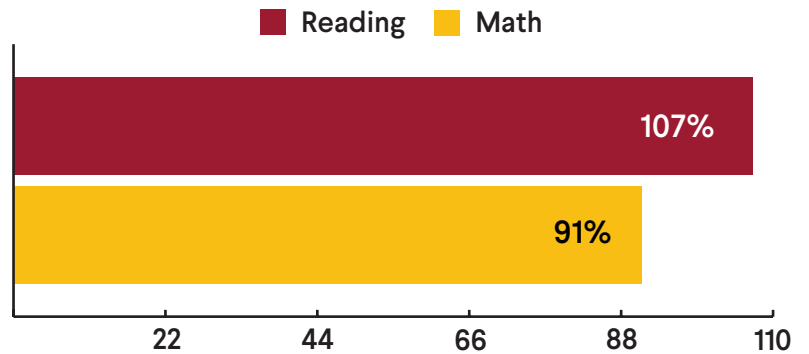
